



Pool Rules – Villa Aliara Vodice (Croatia)

Version: June 2026

These Pool Rules are intended to ensure the safety of all guests and to protect the swimming pool facilities of Villa Aliara Vodice. By using the pool, all guests acknowledge and agree to comply with the following regulations.

1. General Use

1. The swimming pool is exclusively available to registered guests of Villa Aliara.
 2. Use of the pool is entirely at the guest's own risk.
 3. The pool may be used daily from **08:00 a.m. to 10:00 p.m.** Use outside these hours is prohibited for safety and noise protection reasons.
 4. The landlord does not provide supervision of pool users.
 5. The pool may only be used by persons who are physically and medically fit to do so.

2. Children and Supervision

1. Children under the age of 16 may only use the pool under the constant supervision of a responsible adult.
 2. Parents or legal guardians are fully responsible for their children.
 3. Non-swimmers may only use the pool with appropriate flotation devices and under direct supervision.
 4. The duty of supervision cannot be transferred to the landlord or any third party.

3. Hygiene Regulations

1. Showering before entering the pool is mandatory.
 2. Persons suffering from contagious diseases, open wounds, or skin infections are not permitted to use the pool.
 3. The use of oils, lotions, or strongly staining cosmetic products immediately before swimming should be avoided.
 4. Diapers are only permitted if they are specifically designed as swim diapers.
 5. Urinating in the pool or otherwise contaminating the pool water is strictly prohibited.

4. Safety Regulations

The following activities are strictly prohibited in and around the pool:

- Jumping from the pool edge
- Pushing other persons into the pool
- Running around the pool area
- Diving while carrying glass objects
- Throwing objects into the pool
- Dangerous games, horseplay, or dares
- Use of the pool while under the influence of alcohol, drugs, or medication that may impair judgment or reaction time

Use of the pool is entirely at the user's own risk.

5. Food, Drinks and Glassware

1. Glass bottles, drinking glasses, and other breakable objects are not permitted in the pool area.
 2. Food and beverages must not be brought into the pool.
 3. Any contamination caused by guests must be cleaned up immediately by the person responsible.

6. Pets

1. Pets are not permitted in the swimming pool.
 2. Swimming or bathing animals in the pool is strictly prohibited.
 3. If animal hair or contamination requires special cleaning or replacement of pool filters, the guest will be charged the actual costs incurred, with a minimum charge of **€150.00**.

7. Liability

1. Use of the pool is entirely at the guest's own risk.
2. The landlord shall only be liable for damages resulting from intentional misconduct or gross negligence.
3. Liability for accidents, injuries, loss of valuables, or property damage is excluded to the extent permitted by applicable law.
4. The landlord accepts no liability for personal belongings brought onto the property.

5. Guests are liable for all damages caused by themselves, their fellow travelers, or visitors to the pool, technical equipment, or other property.

8. Damage and Contamination

1. Any damage to or malfunction of the pool facilities must be reported to the landlord immediately.
 2. Guests are fully liable for repair or restoration costs resulting from damage caused by them.
 3. Extraordinary contamination of the pool (e.g., vomit, feces, animal hair, beverages, food, or other foreign substances) may require a chargeable special cleaning.
 4. The cost of such special cleaning shall be at least **€150.00** and may be higher depending on the actual expenses incurred.

9. Technical Equipment

1. Pool equipment, filtration systems, lighting, and control systems may only be operated by the landlord or persons authorized by the landlord.
 2. Tampering with technical equipment is strictly prohibited.
 3. Any damage resulting from improper operation shall be charged to the responsible guest.

10. Weather Conditions and Force Majeure

1. In the event of thunderstorms, storms, or other dangerous weather conditions, the pool must be vacated immediately.
 2. The landlord reserves the right to temporarily close the pool for safety reasons or maintenance work.
 3. Temporary unavailability of the pool does not entitle guests to a rent reduction, refund, or compensation unless caused by gross negligence on the part of the landlord.

11. Violations of the Pool Rules

In the event of violations of these Pool Rules, the landlord may prohibit further use of the pool at any time.

Serious or repeated violations may result in immediate termination of the rental agreement without any entitlement to a refund.

By entering and using the swimming pool, guests confirm that they have read, understood, and accepted these Pool Rules.
